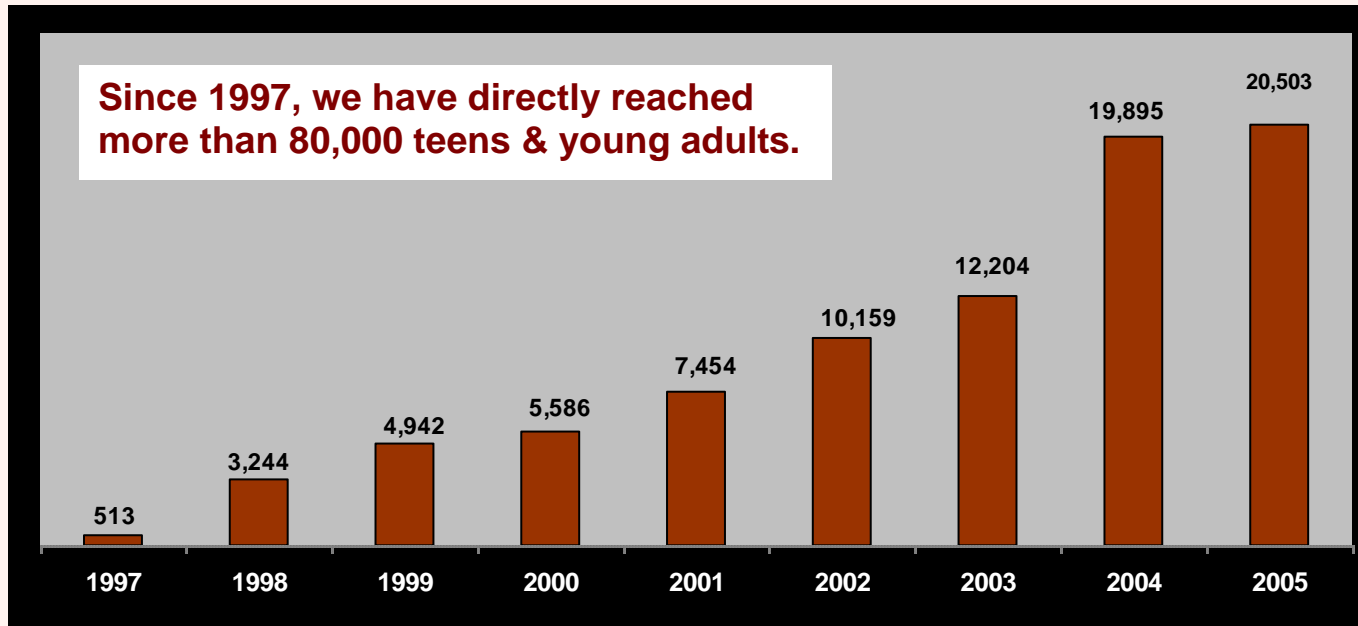
**You have the right to a safe and healthy relationship...

A survey of high school students found almost half of all respondents—46% of girls and 43% of boys—reported experiencing physical aggression at the hands of a dating partner.<sup>1</sup>

Founded in 1996, Break the Cycle takes action against domestic abuse by reaching teens as they are beginning to form their first dating relationships.

Domestic violence costs the United States between five and ten billion dollars annually in health care, law enforcement, social services and missed work.<sup>2</sup>

Break the Cycle's *Ending Violence* curriculum helps stop violence before it starts.

Twelve states will not grant domestic violence restraining orders to teens who are dating.

Break the Cycle educates policy makers about the need to protect victims of domestic violence in all kinds of relationships.

73% of young people say they would turn to a friend if they were in an abusive relationship.<sup>3</sup>

Break the Cycle Peer Leaders are trained to help friends in need.

# our programs

## **ENGAGING**

We break the cycle before it starts by reaching youth, through youth. Break the Cycle's peer leadership program actively engages, trains and mobilizes teens to speak out against domestic violence. In 2005, our Peer Leaders took action in their communities through youth-led projects including the development of a teen action toolkit, policy efforts, poster contests, educational presentations and school-wide assemblies.

## **EDUCATING**

Break the Cycle teaches teens about domestic violence, healthy relationships and the law. We train service-providers to recognize abuse among teens and to respond with confidence and sensitivity. We adapted our curriculum to further meet the diverse needs of youth including pregnant and parenting teens, Latino youth and the LGBTQ community. We launched the conversion of our curriculum into the **Ending Violence DVD Project** to reach as many teens as possible with life-saving domestic violence prevention information.

## **EMPOWERING**

Through our legal services program, Break the Cycle provides holistic, comprehensive early-intervention services including legal advice, advocacy, crisis intervention and safety-planning, to hundreds of young people each year. We operate a toll-free helpline and referral service to assist youth. Additionally, through local and national policy efforts, we work to ensure that teens are able to get help and support they need.

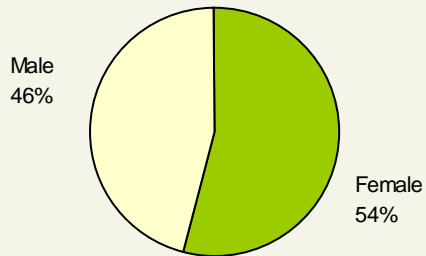

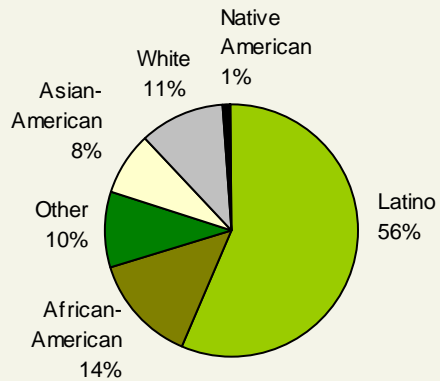

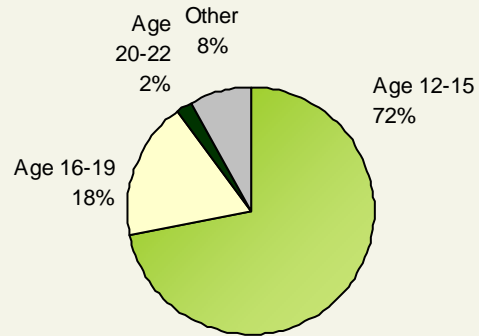
By Gender



By Ethnicity

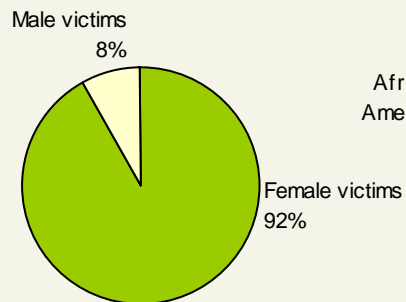


By Age

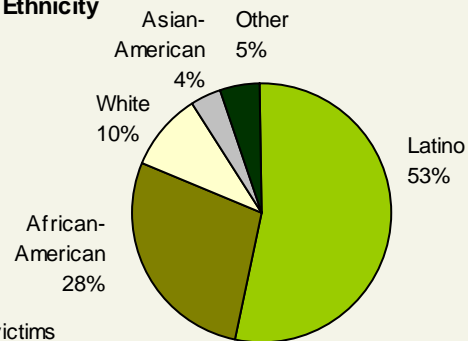

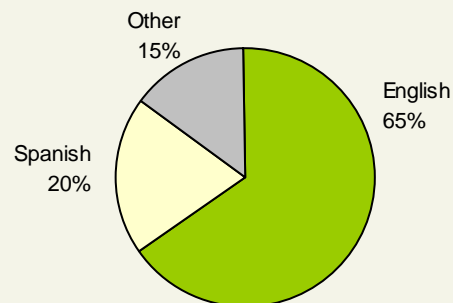
By Gender

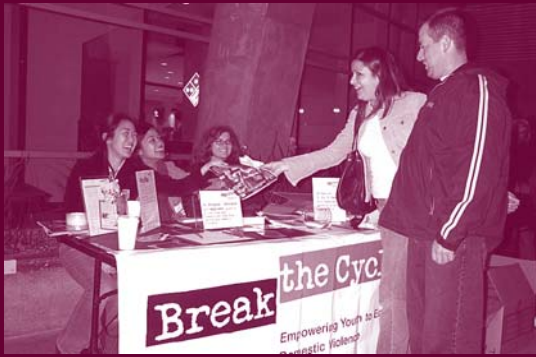
Clients by Primary Language
